# **APPLICATION**

## SURFACE PREPARATION

Cement bound surfaces must be dry, firm, offer good traction, free from loose particles, dust and dirt and additionally free of oil, grease and other impurities.

## MIXING

FIBCURE WB (WHITE) requires no pre-blending and should be used directly from the container but stir well before use.

## **APPLYING AND LAYING**

Apply at a uniform coverage by spray or roller application. Product may be sprayed with a hand held "pump-up" sprayer or with an airless industrial sprayer. If roller applied, use a short napped, solvent resistant sleeve.

## • SEALING APPLICATION

When sealing old concrete, the surface must be clean and dry. Remove contaminants and stains such as grease and oil with strong soaps or caustics rather than acids. Badly worn or porous areas may need a second application to attain a uniform seal and surface gloss.

## **CLEAN UP**

Clean all tools immediately after use with water. Do not allow material to harden. Any hardened material will need to be removed mechanically.

## PACKAGING

FIBCURE WB (WHITE) available in 5 kg can, 15 kg can set, 20 kg bucket and 200 kg barrel.

## STORAGE

Store the material at temperatures between  $+ 10^{\circ}$  C and  $+ 45^{\circ}$  C in originally sealed packages, the material can be stored for 6 months. But before opening the drums, be assured that the temperature of the materials has the ambient temperature to avoid condensation. Open containers of material should be used quickly to avoid moisture contamination.

#### CURING APPLICATION

For the best cure of freshly placed concrete, apply FIBCURE WB (WHITE) as soon as possible after finishing operations and/or immediately after the disappearance of the "sheen" of surface moisture.

### PRECAUTIONS

During mixing and application the following precautions should be observed: ensure adequate ventilation and avoid contact of the material with the eyes, nasal passages, mouth and unprotected skin. Avoid contact with the hands by wearing protective gloves and busing, if necessary, a suitable barrier cream.
