APPLICATION METHODOLOGY

SURFACE PREPARATION

FIBSEAL PUR PRIMER 2K should be applied to

uniform manner, making sure recesses and edges are thoroughly coated / primed. Do not apply if relative humidity exceeds 85%. Recommended coverage rate: 0.15 kg/m2.More separate layers might be needed depending on the soundness of the substrate.

CLEAN UP

• Clean all tools immediately after use with Fibrex Paint Remover. Do not allow material to harden.

STORAGE

Store the material at temperatures between $+ 20^{\circ}$ C and $+ 30^{\circ}$ C in originally sealed packages, the material can be stored for three months. But, before opening the drums, be assured that the temperature of the materials has the ambient temperature to avoid condensation. Open containers of material should be used quickly to avoid moisture contamination.
